- (3) 第一按揭貸款自支取日起計的首 36 個月為供息不供本。首 24 個月的利率為 2%,第 25 個月至第 36 個月的利率為 3%,第 37 個月至第 60 個月的利率以中國銀行(香港)有限公司不時報價之港元最優惠利率("P")計算,第 61 個月及 其後的利率以 P 加 2% (P + 2%) 計算。P 隨利率浮動調整。利率以指定財務機構最終審批結果決定。利率是指年利率。
